ORDINANCE No. 109

ORDINANCE TO RESCIND SECTION 4.13 CO CONSERVATION OVERLAY FROM THE BOONE COUNTY ZONING ORDINANCE NO. 88, ADOPTED JULY 1, 2008

WHEREAS, at certain times it is necessary to amend the text component and official map component of the Boone County Zoning Ordinance when addressing issues of growth, farmland preservation, conservation, and desires of the property owner and citizens.

WHEREAS, Iowa Chapter 335 County Zoning, Section 335.6 Procedure – Hearing – Notice states that regulation, restriction, or boundary shall *not* become effective until after a public hearing, at which parties in interest and citizens shall have an opportunity to be heard.

WHEREAS, the Board of Supervisors shall *not* hold its public hearings or take action until it has received the Final Report from the Planning and Zoning Commission per Chapter 335 County Zoning, Section 335.8 Commission appointed-powers and duties.

WHEREAS, the Planning and Zoning Commission did, with due diligence, hold a public hearing on Monday, February 28, 2011 to consider Petition 30 November 2010 to have Section 4.13 CO Conservation Overlay District rescinded/removed from Zoning Ordinance No. 88, passed and adopted July 1, 2008.

**WHEREAS**, the Final Report to the Boone County Board of Supervisors recommending that Section 4.13 CO Conservation Overlay be rescinded/removed was submitted by Chairman of the Boone County Zoning Commission.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF BOONE COUNTY, IOWA AS FOLLOWS:

## **SECTION ONE:**

That the Boone County Board of Supervisors shall and it does hereby rescind Section 4.13 CO Conservation Overlay from Boone County Zoning Ordinance No. 88, passed and adopted July 1, 2008.

**SECTION TWO:** That this amendment shall be in full force and effect from and after its passage and approval in the manner provided by law.
