TEXT AMENDMENT TO THE BOONE COUNTY ZONING ORDINANCE – AMENDING SECTION 4.16 USE TABLE, TO ADD "CATERING SERVICE, BANQUET/RECEPTION FACILITY, SOCIAL OR FRATERNAL ORGANIZATION" AS A CONDITIONAL USE IN THE A-1 DISTRICT

WHEREAS, at certain times it is necessary to amend the text component and official map component of the Boone County Zoning Ordinance when addressing issues of growth, farmland preservation, conservation, and desires of the property owner and citizens.

WHEREAS, Iowa Chapter 335 County Zoning, Section 335.6 Procedure – Hearing – Notice states that regulation, restriction, or boundary shall *not* become effective until after a public hearing, at which parties in interest and citizens shall have an opportunity to be heard.

WHEREAS, the Board of Supervisors shall *not* hold its public hearings or take action until it has received the Final Report from the Planning and Zoning Commission per Chapter 335 County Zoning, Section 335.8 Commission appointed-powers and duties.

WHEREAS, the Planning and Zoning Commission did, with due diligence, hold a public hearing on Tuesday, December 10, 2019 for the purpose of amending section 4.16 Use table, to add "Catering service, banquet/reception facility, social or fraternal organization" as a conditional use in the A-1 district.

WHEREAS, the Boone County Zoning Commission submitted a Final Report to the Boone County Board of Supervisors recommending approval of the amendment to Section 4.16 Use Table
