#### **BOONE COUNTY ORDINANCE 147**

An Ordinance prescribing Boone County Voting Precincts Effective January 15<sup>th</sup>, 2022, in accordance with Iowa Law, based on the 2020 U.S. Census.

### Section 1: Purpose

Voting precincts located in Boone County are hereby redrawn based on the 2020 U.S. Census. The new precinct lines become effective January 15<sup>th</sup>, 2022 and remain effective until revised by the 2030 U.S. Census.

The Boone County voting precincts are described generally as follows:

Rural Precinct 1 Harrison Township; Jackson Township; and the portion of

Colfax Township north of 230th Street

Rural Precinct 2 City of Luther; Colfax Township excluding the portion north of

230<sup>th</sup> Street; Garden Township including that part of City of Sheldahl in Boone County and excluding City of Madrid; and

Worth Township excluding the northwest most portion

Rural Precinct 3 Peoples Township; Cass Township; and Douglas Township

excluding City of Madrid

Rural Precinct 4 City of Berkley; Beaver Township; Marcy Township excluding City

of Ogden; and Union Township

Rural Precinct 5 City of Fraser; Amagua Township including City of Beaver; Grant

Township including the City of Boxholm; Pilot Mound Township including the City of Pilot Mound; and Yell Township excluding

City of Ogden

Rural Precinct 6 Des Moines Township excluding City of Boone and Dodge

Township except City of Fraser

Each of the above-described precincts will have one polling location as established by the Boone County Auditor in compliance with all applicable federal and state laws.

## Section 2: Voting Precinct Boundaries Defined

Boone 1 Precinct: All that portion of the City which lies within the area described as beginning at the intersection of Marshall Street and 15th Street, thence West to Story Street, thence South to 5th Street, thence East to Delaware Street, thence South to Mamie Eisenhower Avenue, thence East following Mamie Eisenhower Avenue to Quartz Avenue, thence North reaching corporate limits, thence West following corporate limits to a point on the North line of 7th Street to a point that the corporate limits head North, thence North, East, South Easterly and then North following corporate limits to Industrial Park Road, thence West and North following corporate limits to a point on the South line of the Boone and Scenic Valley Railroad right-ofway, thence East to Quartz Avenue, thence North, West and South following corporate limits to a point on the North line of the Boone and Scenic Valley Railroad right-of-way, thence West, North and back West to Curtis Street, thence North to the Northern boundary of corporate limits which is also 22nd Street, thence West to Marshall Street, thence South to the point of beginning, shall constitute and is denominated the first ward of the City of Boone.

**Boone 2 Precinct:** All that portion of the City which lies within the area described as beginning at the intersection of 5th Street and Cedar Street, thence South to Union Street, thence West to S. Marshall Street, thence South to Hawkeye Drive, thence West to S. Story Street, thence South to the Southern boundary of corporate limits which is also 223rd Place, thence East to a point that corporate limits turn South, thence following corporate limits South, East, South, Northeasterly, East and then North to a point that corporate limits then head East for a distance reaching the Southeast corner of corporate limits, thence North for a distance until the corporate limits head East, South, East, North, West, North, and West which is all following corporate limits, thence North 210th Street, thence Westerly following 210th Street which turns into Mamie Eisenhower Avenue to Delaware Street, thence North to 5th Street, thence West to the point of beginning, shall constitute and is denominated the second ward of the City of Boone.

**Boone 3 Precinct:** All that portion of the City which lies within the area described as beginning at the intersection of Union Street and S. Marshall Street, thence East to S. Cedar Street, thence North to 5th Street, thence West to Harrison Street, thence North to 6th Street, thence West to Milwaukee Street, thence South to Mamie Eisenhower Avenue, thence West to S. Division Street, thence South to W. Park Avenue, thence East to Southridge Drive, thence Southerly following the corporate limits to a point that the corporate limits head East, thence East, South and West following corporate limits to a point that they head South to the Southern boundary of corporate limits, thence East to S. Story Street, thence North to Hawkeye Drive, thence East to S. Marshall Street, thence North to the point of beginning, shall constitute and is denominated the third ward in the City of Boone.

**Boone 4 Precinct:** All that portion of the City which lies within the area described as beginning at the intersection of 5th Street and Story Street, thence North to 15th Street, thence East to Marshall Street, thence North to 22nd Street, thence West to Division Street, thence South to a point that the corporate limits head West, thence back South and East to Division Street, thence South to W. 18th Street, thence West following corporate limits to a point that they head back South, East and then South and East again reaching Division Street, thence South to the North line of 16th Street, thence West and meandering around the established corporate limits until reaching a point on the centerline of W. 15th Street, thence West to the West line of the Boone and Scenic Valley Railroad right-of-way, thence Southeasterly to Marion Street, thence South to

West 12th Street, thence West to State Street, thence South to West 10th Street, thence East to Division Street, thence South to West 8th Street, thence East to Harrison Street, thence South to 5th Street, thence East to the point of beginning, shall constitute and is denominated the fourth ward in the City of Boone.

Boone 5 Precinct: All that portion of the city which lies within the area described as beginning at the intersection of 8th Street and Harrison Street, thence West to Division Street, thence North to W. 10th Street, thence West to State Street, thence North to W. 12th Street, thence West to the Western boundary of corporate limits, thence South to a point that the corporate limits head East, thence East to Montana Road, thence South to a point that the corporate limits head back East, thence East following corporate limits turning Northeasterly to W. Park Avenue, thence East to the West line of S. Marion Street, thence South, West, South and East around a property within corporate limits to the East line of S. Marion Street, thence North to W. Park Avenue, thence East to a point that corporate limits head South, thence South, East and North following corporate limits to W. Park Avenue, thence East to S. Division Street, thence North to W. 3rd Street, thence East to Milwaukee Street, thence North to 6th Street, thence East to Harrison Street, thence North to the point of beginning, shall constitute and is denominated the fifth ward in the City of Boone.

**Madrid 1 Precinct:** All that portion of City of Madrid that lies within the area described as beginning at the intersection of E. North Street and 330th Street, thence following the corporate limits East, North then back West to a point, continuing North following the corporate limits to the Northeast corner of Tiger Run Subdivision, thence following corporate limits West, then North to a point on the Northern boundary of corporate limits, thence West and South following corporate limits to a point where the corporate limits head back West to the centerline of N. Water Street, thence South to E. 22nd Street, thence East to N. Union Street, thence South to W. First Street, thence West to S. State Street, thence South to E. Sixth Street, thence East to S. Kennedy Avenue, thence North to E. Third Street, thence East to Green Street, thence North to E. Second Street, thence East to S. County Line Road which is also corporate limits, thence North to the point of beginning, shall constitute and is denominated the first ward in the City of Madrid.

**Madrid 2 Precinct:** All that portion of the city which lies within the area described as beginning at the intersection of E. Second Street and S. County Line Road, thence West to Green Street, thence South to E. Third Street, thence West to Highway 17 or S. Kennedy Avenue, thence South to E. Sixth Street, thence West to S. State Street, thence North to W. Fifth Street, thence West to S. Market Street, thence South to W. Eighth Street, thence West to corporate limits, thence South, East and back South following corporate limits to the Southern most boundary of corporate limits, thence West still following corporate limits to S. Kennedy Avenue, thence North and West following the Southern boundary of corporate limits to the Eastern boundary of corporate limits, thence North to the point of beginning, shall constitute and is denominated the second ward in the City of Madrid.

**Madrid 3 Precinct**: All that portion of the city which lies within the area described as beginning at the intersection of E. 22nd Street and N. Union Street, thence West to N. Water Street, thence North to the Northern boundary of corporate limits, thence West and South following corporate limits to W. North Street or 334th Street, thence West, South and back East following corporate limits to W. Fourth Street, thence South, West and back South following corporate limits to W. Eighth Street, thence East to S. Market Street, thence North to W. Fifth Street, thence East to S. State Street, thence North to W. First Street, thence East to N. Union Street,

thence North to the point of beginning, shall constitute and is denominated the third ward in the City of Madrid.

**Ogden Precinct:** Bounded by the city limits of the City of Ogden, Iowa.

**Rural Precinct 1:** Generally described as Harrison Township; Jackson Township; and the portion of Colfax Township north of 230<sup>th</sup> Street. Bounded as follows, beginning at the intersection of Y Avenue and 100th Street, thence West to the centerline of S Avenue, thence South to 220th Street (at this point also known as State Highway 30), thence East following State Highway 30 until reaching W. Lincoln Way, thence continuing East on W. Lincoln Way to the centerline of Y Avenue, thence North to the point of beginning, shall constitute and is denominated Rural Precinct 1 in Boone County, lowa.

Rural Precinct 2: Generally described as the City of Luther; Colfax Township excluding the portion north of 230th Street; Garden Township including that part of City of Sheldahl in Boone County and excluding City of Madrid; and Worth Township excluding the northwest most portion. Bounded as follows, beginning at the intersection of W. Lincoln Way and Y Avenue, thence West to State Highway 30, thence continuing West on State Highway 30 to the Eastern boundary of the city limits of Boone, thence Southerly, Easterly, Southerly, Northerly and Westerly following the city limits of Boone to the centerline of S. Story Street, thence South to the centerline of 230th Street, thence West and South following 230th Street to 231st Road. thence following 231st Road which meanders Westerly, Southerly, Westerly and Northerly until it turns into Montana Road, thence West to the centerline of the Des Moines River at a point that Montana Road heads in a Northeasterly direction, thence Southerly meandering along the centerline of the Des Moines River to the centerline of 280th Street, thence East to the centerline of S Avenue, thence South to the Northerly boundary of the city limits of Madrid, thence Easterly, Southerly and Westerly following the city limits of Madrid to the centerline of S Avenue, thence South to the centerline of 340th Street, thence East to the centerline of Y Avenue, thence North to the point of beginning, shall constitute and is denominated Rural Precinct 2 in Boone County, Iowa.

**Rural Precinct 3:** Generally described as Peoples Township; Cass Township; and Douglas Township excluding City of Madrid. Bounded as follows, beginning at the intersection of S Avenue and 280th Street, thence West to the centerline of G Avenue, thence South to the centerline of 340th Street, thence East to the centerline of S Avenue, thence Easterly, Northerly and Westerly around the city limits of Madrid to the centerline of S Avenue, thence North to the point of beginning, EXCEPT the City of Madrid, shall constitute and is denominated Rural Precinct 3 in Boone County, Iowa.

Rural Precinct 4: Generally described as the City of Berkley; Beaver Township; Marcy Township excluding City of Ogden; and Union Township. Bounded as follows, beginning at the intersection of 220th Street and the Des Moines River, thence West to the city limits of Ogden, thence Southerly, Westerly and Northerly around the city limits of Ogden to the centerline of 220 Street, thence West to the centerline of A Avenue, thence South to the centerline of 340th Street, thence East to the centerline of G Avenue, thence North to the centerline of 280th Street, thence East to the centerline of the Des Moines River, thence Northwesterly meandering along the Des Moines River to the point of beginning, shall constitute and is denominated Rural Precinct 4 in Boone County, Iowa.

**Rural Precinct 5:** Generally described as the City of Fraser; Amaqua Township including City of Beaver; Grant Township including the City of Boxholm; Pilot Mound Township including the City of Pilot Mound; and Yell Township excluding City of Ogden. Bounded as follows, beginning at the intersection of 100th Street and the centerline of the Des Moines River, thence West to the centerline of A Avenue, thence South to the centerline of 220th Street, thence East to the Western boundary of the city limits of Ogden, thence following the city limits of Ogden Northerly, Easterly and Southerly to the centerline of 220th Street, thence East to the centerline of the Des Moines River, thence Northerly meandering along the Des Moines River to the point of beginning, shall constitute and is denominated Rural Precinct 5 in Boone County, Iowa.

Rural Precinct 6: Generally described as Des Moines Township excluding City of Boone and Dodge Township except City of Fraser. Bounded as follows, beginning at the intersection of 100th Street and S Avenue, thence West to the centerline of the Des Moines River, thence Southerly meandering along the Des Moines River to the Northerly boundary of the city limits of Fraser, thence Easterly and Southerly along the city limits of Fraser to the centerline of the Des Moines River, thence meandering Southerly along the Des Moines River to a point that is an extension of a point on Montana Road where it heads Northeasterly, thence East to Montana Road, thence Southerly and Easterly following Montana Road until it turns into 231st Road, continuing on 231st Road until reaching Oriole Road which is also known as 230th Street, thence Northeasterly along 230th Street, until reaching the centerline of S. Story Street, thence North to the Southern boundary of the city limits of Boone, thence following the city limits of Boone as they meander Easterly, Southerly, Northerly, Easterly and Northerly to the centerline of 220th Street, thence East to the centerline of S Avenue, thence North to the point of beginning, EXCEPT the City of Boone, shall constitute and is denominated Rural Precinct 6 in Boone County, lowa.

## Section 3: Repealer

All ordinances in conflict herewith are repealed.

# Section 4: Severability Clause

If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity or the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

#### Section 5: When Effective

Boone County Board of Supervisors

This ordinance shall be in effect after its passage, approval and publication as provided by law.
