ORDINANCE NO. 49

ORDINANCE AMENDING THE OFFICIAL BOONE COUNTY ZONING MAP

AMENDMENT TO REDESIGNATE PART OF THE SW $\frac{1}{4}$ OF THE SE $\frac{1}{4}$ OF SECTION 26-82-26, BOONE COUNTY, IOWA, CONTAINING LOTS 1-10 OF SWEDE POINT SUBDIVISION FROM A-1 (AGRICULTURE) TO R-1 (RESIDENTIAL) AS IDENTIFIED ON THE ATTACHED MAP.

WHEREAS, In this case, Allen and Harold Olson petitioned Boone County to rezone the property described hereinabove from A-1 (Agriculture) to R-1 (Residential) to accommodate a residential subdivision.

WHEREAS, The Director of Planning and Development forwarded a recommendation for approval to the Boone County Zoning Commission. The Zoning Commission held a public hearing on April 28, 2003 in accordance with Iowa Code. The Zoning Commission accepted a motion of "recommendation of approval" to the Boone County Board of Supervisors for the rezoning at the property noted hereinabove.

WHEREAS, According to the Boone County Land Division Ordinance property is to be rezoned to the appropriate use prior to Final Plat Approval of a Major Subdivision. The passage of this amendment will accomplish that requirement for Swede Point Subdivision.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF BOONE COUNTY, IOWA AS FOLLOWS:

SECTION ONE: That Boone County shall, and it does hereby, approve an amendment to the Official Zoning Map that the property legally described as follows: PART OF THE SW ¼ OF THE SE ¼ OF SECTION 26-82-26, BOONE COUNTY, IOWA, CONTAINING LOTS 1-10 OF SWEDE POINT SUBDIVISION, BE RE-ZONED FROM A-1 (AGRICULTURE) to R-1 (RESIDENTIAL).

That this amendment shall be in full force and effect from and after its passage and approval in the manner provided by law.
