

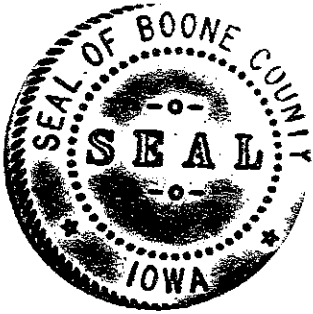

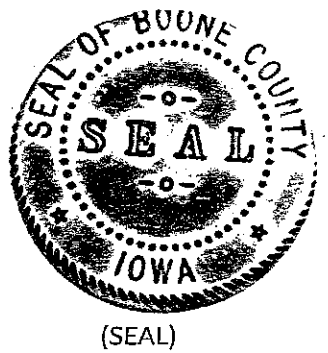

PUBLIC MEASURE LETTER MB  
SHALL THE FOLLOWING PUBLIC MEASURE BE ADOPTED?**

Shall the Board of Directors of the Madrid Community School District in the Counties of Boone, Polk, and Dallas, State of Iowa, be authorized to levy annually a tax exceeding Two Dollars and Seventy Cents (\$2.70) per Thousand Dollars (\$1,000), but not exceeding Three Dollars and Fifty Cents (\$3.50) per Thousand Dollars (\$1,000) of the assessed value of the taxable property within said school corporation to pay the principal of and interest on bonded indebtedness of said school corporation, it being understood that the approval of this proposition shall not limit the source of payment of the bonds and interest, but shall only operate to restrict the amount of bonds which may be issued?
