**WHEREAS**, the County Board of Supervisors has determined that the adoption and implementation of the proposed comprehensive plan update is in the best interest of the County with respect to satisfying the County's statutory duties.

**Boone County, t**hat the proposed comprehensive plan update is hereby adopted as the comprehensive solid waste management plan of the County.
