Hollingshead moved Foster seconded adopting proposed amendment to the Boone County Employee Handbook – Tobacco-Nicotine Policy as follows. No: None; Yes: Duffy, Foster, Hollingshead. Motion passed.

The use of any tobacco/nicotine product is prohibited inside county buildings, grounds (unless in a designated area), vehicles or equipment. In addition, the use of tobacco or nicotine products is not allowed in any other areas designated and posted as a non-smoking area. This includes cigarettes, e-cigarettes (vaping), snus, chew, cigarillos, any other product containing nicotine or tobacco, any new or emerging tobacco-nicotine product or simulated smoking device, including the use of nicotine products that are not FDA (Food and Drug Administration) approved for tobacco cessation. Any employee who violates this policy will be subject to disciplinary action, up to and including discharge.

Hollingshead moved Foster seconded motion to approve drainage service proposal from ISG Group for Drainage District No. 222 to study and prepare an engineering study to discuss with drainage district property owners at a public hearing. No: None; Yes: Duffy, Foster, Hollingshead. Motion passed.
