Adopting Central Iowa Regional Transportation Planning Alliance 28E Agreement

Whereas, the Boone County Board of Supervisors is empowered under the provisions of the Iowa Code Chapter 28E to enter into agreements with other governmental entities;

BE IT RESOLVED that the Boone County Board of Supervisors does hereby adopt this resolution 15-35 approving the Central Iowa Regional Transportation Planning Agency (CIRTPA) 28E Agreement for establishing a multi-county regional transportation planning group to provide transportation planning services for using certain state and federal high funds.
