RESOLUTION FOR ESTABLISHING SPEED LIMITS

Boone County Resolution No. 16-05

WHEREAS, the Board of Supervisors is empowered under authority of the Iowa Code Sections 321.255 and 321.285 of the Code of Iowa, to determine upon the basis of an engineering and traffic investigation, that the speed limit of any secondary road is greater than is reasonable and proper under the conditions existing, and may determine and declare a reasonable and proper speed limit, and

WHEREAS, such an investigation has been requested and has been completed by the Boone County Engineer, and

WHEREAS, an existing 45 mph speed limit lowers the speed limit from 55 mph along 130^{th} Street, it is recommended to extend that to encompass all local roads leading into the town of Pilot Mound.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF BOONE COUNTY that the speed limit be established and appropriate signs be erected at the location described as follows:

Beginning at a point 880 feet West of Pilot Street on 130th Street in Pilot Mound, extending a distance of 3,480 feet to the East on 130th Street to the other side of I Ave. This 3,480 feet stretch to be established a 45 mile per hour speed limit zone.

RESOLUTION SUMMARY – ESTABLISH THE PURPOSE FOR APPLYING FOR THE REVITALIZE IOWA'S SOUND ECONOMY IMMEDIATE OPPORTUNITY GRANT, IN COOPERATION WITH THE CITY OF BOONE.

WHEREAS, the Boone County Board of Supervisors and Boone City Council endorse the project; and

WHEREAS, the Boone County Board of Supervisors and Boone City Council have an immediate, non-speculative opportunity for permanent job creation; and

WHEREAS, the Boone County Board of Supervisors and Boone City Council are currently negotiating with KemX Global to bring a new facility to Boone County; and
