Board reviewed budgeted figures as presented. They agreed to allow the hiring of an additional deputy to be funded from using Sec. 356.7 funds 40% of which accumulate in the general fund and must be budgeted for use with the agreement of Board of Supervisors and the Sheriff. This should eliminate a considerable amount of overtime. Board also requested Sheriff to reduce Radio repair to \$8,000 from \$30,000 as the tower is now properly grounded. Sheriff Elsberry agreed to these modifications.

Board also told Meier to reduce salary of the Victim and Witness coordinator proposed to the progressive scale of administrative assistants.
