Board discussed the issue that purchase agreements or leases must officially be signed by them, so the need of a memorandum of understanding must be developed so as the 911 Board and cities understand if county ultimately bonds for project, the payment related to the radios must be contributed to county to pay the share of debt related to radios. If 911 funding is inadequate to do so, 911 Board will need to assess cities for shortfall

Zinnel expressed concern about urgent need when several parts of state system are not currently functional. Also it is his understanding that current system will need to be maintained until counties around us on state system as well.
