RESOLUTION DIRECTING THE ACCEPTANCE OF A PROPOSAL TO PURCHASE \$3,500,000 (DOLLAR AMOUNT SUBJECT TO CHANGE) TAXABLE GENERAL OBLIGATION REFUNDING CAPITAL LOAN NOTES, SERIES 2017

WHEREAS, Boone County, sometimes hereinafter referred to as the County, is a political subdivision duly incorporated, organized and existing under and by virtue of the Constitution and laws of the State of Iowa; and

WHEREAS, it is deemed necessary that the County should enter into a Loan Agreement and borrow the amount of not to exceed \$3,500,000 as authorized by Sections 331.402 and 331.443, Code of Iowa as amended; and

WHEREAS, proposals have been requested and received from financial institutions offering to enter into such Loan Agreement; and

WHEREAS, after a review of all the proposals received, it has been determined that the best and most favorable proposal is that of United Bank of Ida Grove, Iowa and

WHEREAS, it is the intention of this Board of Supervisors to enter into a Loan Agreement in accordance with said proposal dated October 3, 2017.

NOW THEREFORE, BE IT RESOLVED, BY THE BOARD OF SUPERVISORS OF BOONE COUNTY, STATE OF IOWA: That this Board of Supervisors does hereby accept the attached proposal of United Bank of Iowa of Ida Grove, Iowa and takes additional action to permit the entering into of a Loan Agreement.

The Chairperson and County Auditor are authorized and directed to proceed on behalf of the County to enter into such Loan Agreement, to negotiate the final terms of a Loan Agreement, to take all action necessary to permit the entering into of a Loan Agreement on a basis favorable to the County and acceptable to the Purchaser, and to proceed to meet the conditions of this accepted proposal.

WHEREAS, the County did by resolution dated April 28, 2009, authorize the issuance of \$1,550,000 Taxable General Obligation Capital Loan Notes, Series 2009A, (the "Notes") dated May 1, 2009; and

WHEREAS, the Notes are redeemable in any order of their numbering on May 1, 2017 or any date thereafter upon giving notice in the manner provided in the resolution authorizing the issuance of the Notes; and

WHEREAS, it is deemed necessary and advisable that \$1,130,000 be so redeemed on November 15, 2017 and notice of redemption be given according to the terms of the resolution authorizing issuance of the Notes.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF BOONE COUNTY, STATE OF IOWA: That outstanding Taxable General Obligation Capital Loan Notes, dated May 1, 2009, in the principal amount of \$1,130,000, be and the same are hereby redeemed as of November 15, 2017.
