Boone county Resolution 2018 - 13

Whereas: the Board of Supervisors is empowered under authority of Sections 321.236, 321.255, and 321.345 of the Code of Iowa to designate any secondary road intersection under their jurisdiction as a STOP intersection and to erect STOP signs at entrances to such intersection, and

Whereas: westbound traffic on 200th St. is endangered by traffic traveling east on Industrial Park Road at the intersection located at the North ¼ Corner of Section 26, T. 84 N., R. 26 W. of the 5th P.M., Des Moines Township, Boone County, Iowa.

Now, Therefore, Be It Resolved by the Boone County Board of Supervisors that the intersection of Industrial Park Road/200th St. and Quartz Avenue be controlled by a stop sign. This stop condition will apply to the eastbound and westbound traffic on Industrial Park Road/200th St. STOP signs shall be erected accordingly at this intersection.

RESOLUTION FOR ESTABLISHING SPEED LIMITS

Whereas, the Board o Supervisors is empowered under authority of Iowa Code Sections 321.255 and 321.285 of the Code of Iowa, to determine upon the basis of an engineering and traffic investigation, that the speed limit of any secondary road is greater than is reasonable and proper under the conditions existing, and may determine and declare a reasonable and proper speed limit, and

Whereas, such an investigation has been requested and has been completed by the Boone County Engineer.

Now Therefore, Be It Resolved by the Board of Supervisors of Boone County that the speed limit be established and appropriate signs be erected at the location described as follows: Beginning at the intersection of Industrial Park Road/200th Street and Quartz Avenue, extending a distance of 5,090 feet to the West on Industrial Park Road to the existing 35 mph speed limit zone. This 5090 feet stretch to be established as a per hour speed limit zone.
