RESOLUTION NO. 2019 - 15

BE IT HEREBY RESOLVED by the Boone County Board of Supervisors this 24th day of April 2019 that the following order for destruction of noxious weeds be effective immediately.

1. That each owner and each person in the possession or control of any land in Boone County shall cut, burn, spray, or otherwise destroy all noxious weeds thereon and shall prevent weed seeds from blooming or coming to maturity, and shall keep said lands free from such growth of any other weeds as shall render the streets or highways adjoining said land unsafe for public travel.

Noxious weeds shall be cut, burned, sprayed, or otherwise destroyed on or before the following dates and as often thereafter as is necessary to prevent seed productions:

Group 1: June 1, 2019 - for Leafy Spurge, Perennial Peppergrass, Sour Dock, Sheep Sorrow, Canada Thistle, Russian Knapweed, Buckhorn, Wild Mustard, Musk Thistle, Bull Thistle, and all other species of thistle

Group 2: July 1, 2019 - for Field Bindweed, Wild Carrot

Group 3: August 1, 2019- for Horse Nettle, Perennial Sow Thistle, Quack Grass, Butter Print, Puncture Vine, Cocklebur, Hemp, Shatter Cane, Wild Sunflower, and Palmer Amaranth 2. That each owner and person in the possession or control of any lands in Boone County, infested with any noxious weeds, including Quack Grass, Perennial Sow Thistle, Canada Thistle, Field Bindweed, Horse Nettle, Leafy Spurge, Perennial Peppergrass, Russian Knapweed, Hemp, any species of Thistle, and Palmer amaranth shall adopt a program of weed destruction described by the Weed Commissioner, which in five years may be expected to destroy and will immediately keep under control such infestations of said noxious weeds.

- 3. That if the owners or persons in possession/control of any land in Boone County fail to comply with the foregoing order, the Weed Commissioner shall cause this to be done and the expense of said work, including costs of serving notice and other costs, if any, to be assessed against the land and the owners thereof, pursuant to 317.16 and 317.21 of the code of Iowa.
- 4. That the County Auditor be and is hereby directed to cause notice of the making and entering of the foregoing order by one publication in each of the official newspapers of the county.

Whereas both positions were approved for the 2019-2020 budget for the upcoming budget year.

Whereas each position requires personal training on the computer systems, procedures of the office, procedures of the court, and complex and novel issues that requires a transfer of knowledge from the existing person in the position to give to the new person taking over. .

Whereas to properly train the new legal clerk and the new assistant county attorney could take several months the Boone County Attorney's Office is only asking for one month of training overlap for the new person to learn the position with the existing person in the position.

A RESOLUTION TO COMMERATE THE CHANGE OF STATUS OF COUNTY ATTORNEY'S OFFICE ASSISTANT COUNTY ATTORNEY

Whereas Boone County Attorney's Office is authorized by the Board of Supervisors for one full time First Assistant Attorney and one part time attorney.

Whereas the part-time attorney worked from Monday through Thursday for a total of 32 hours per week.

Whereas the part-time attorney was eligible for all the benefits as a full time employee.

Whereas the current part-time attorney is retiring and his last date of employment will be July 5, 2019.

Whereas the legal liabilities and legal responsibilities to the County have increased substantially over the past decade. This was addressed by the Board when they wisely made the Boone County Attorney's position a full-time position in 2013 and further changed the status to a full time assistant position in 2015.

Whereas in the past the part-time assistant attorneys had wages from \$55,000 up to \$63,000 and had full-time private practices on the side.

Whereas the County will greatly benefit with no added cost to the second Assistant County Attorney position from part-time to a full-time position.

Resolved The Assistant County Attorney position that is currently a part-time position is moved to a full-time position.
