WHEREAS, Boone County has located property described as; The North Half of the SE SE (17.97 acres +/-), and the W 7.97 Acres of the North Half SW SE all located in Sec 31, T84N, R25W, Jackson Township, Boone County, Iowa, and

WHEREAS, Boone County has offered Eric R. Ziel and Carol A. Ziel Joint Revocable Trust (Owner) \$455,000 to purchase approximately 26 acres; and

WHEREAS, Eric R Ziel and Carol A. Ziel Joint Revocable Trust have agreed to sell said 26 acres for price of \$455,000.
