All ayes. Motion carried.

Chairman Duffy opened the Public Hearing to vacate and transfer the 16' wide alley abutting Lots 1 through 6, and 24' wide alley abutting Lots 7 and 8 in Block 13, Blair's Addition to the Town of Moingona, Marcy Township, Boone County, to abutting property owners at 10:15 a.m. No comments written or oral were presented. Zinnel moved Kretzinger seconded motion to close the hearing at 10:18 a.m. Zinnel moved Kretzinger seconded motion to adopt RESOLUTION 2022-30: A resolution vacating and transferring the 16 foot wide alley abutting Lots 1 through 6, and 24' wide alley abutting Lots 7 and 8 in Block 13, Blair's Addition to the Town of Moingona, Marcy Township, Boone County, to abutting property owners. All ayes. Motion carried.

#### **RESOLUTION 22-30**

A resolution vacating and transferring the 16 foot wide alley abutting lots 1 through 6, and 24' wide alley abutting lots 7 and 8 in Block 13, Blair's Addition to the Town of Moingona, Marcy Township, Boone County, to abutting property owners.

**WHEREAS**, Boone County was the recipient of the dedicated streets and alleys of the plating process of the Village of Moingona, and

**WHEREAS**, Boone County has received a petition from adjacent landowners requesting the County to vacate and abandon the 16 foot wide alley abutting lots 1 through 6, and 24' wide alley abutting lots 7 and 8 in Block 13, and

**WHEREAS**, all existing utilities within the right-of-way of the existing roadway shall continue to have the right to access those utilities and make the necessary repairs and upgrades, and

**WHEREAS**, Boone County did conduct a public hearing at 10:15 a.m. on October 12, 2022, with notice of same being published in the Boone News-Republican on October 6, 2022 and caused same notice to be sent by certified mail to abutting property owners in accordance with Code of Iowa 306.12.

**BE IT RESOLVED**, that vacation and abandonment is granted and the vacated alley shall be transferred to the owners of the abutting lots as follows, subject to existing utility easements:

- 1. The Northeasterly ½ of said alley shall be transferred to the owner of Lots 1 through 4 of Block 13.
- 2. The Southwesterly ½ of said alley shall be transferred to the owners of Lots 5 through 9 of Block 13.

**BE IT FUTHER RESOLVED**, that the Chairman of the Board of Supervisors and the County Auditor are hereby authorized and directed to sign this resolution and cause it to be recorded as the document transferring said vacated street and alleys.
