Public Measure VS

SHALL THE FOLLOWING PUBLIC MEASURE BE ADOPTED?

"Shall the Southeast Webster Grand Community School District, located in Boone, Greene, and Webster Counties, State of Iowa, and the Prairie Valley Community School District, located in Calhoun, Greene, and Webster Counties, State of Iowa, be reorganized into a new school district and school corporation to be known as the Southeast Valley Community School District, pursuant to the provisions of Chapter 275, Code of Iowa, and effective July 1, 2023, to include all of the current territory of both districts as legally described in the Prairie Lakes Area Education Agency Board of Director's Ruling and Order published in The Messenger, Fort Dodge, Webster County, Iowa on September 29, 2021, and with an initial board of seven (7) directors appointed from existing Boards pursuant to Section 275.41, Code of Iowa (the alternative method of carryover appointments), with three (3) directors initially appointed from the Southeast Webster Grand Community School District Board of Directors and three (3) directors initially appointed from the Prairie Valley Community School District Board of Directors, with the seventh director to be unanimously appointed or specially elected, and a regular Board of seven (7) directors elected thereafter pursuant to Section 275.12(2)(c), Code of Iowa, with one (1) director elected at large and six (6) directors from and as residents of two designated multi-member director districts on the basis of population, who shall be a resident of the respective director district but who shall be elected by a vote of the electors of the entire District, and with the immediate merger of the entirety of the assets and liabilities of the two present Districts on the effective date of the reorganization, July 1, 2023?"

SHALL THE FOLLOWING PUBLIC MEASURE BE ADOPTED?

Summary; To adopt a Revenue Purpose Statement specifying the use of revenues the Southeast Valley Community School District will receive from the State of Iowa Secure an Advanced Vision for Education Fund, beginning July 1, 2023.

In the Southeast Valley Community School District, the following Revenue Purpose Statement which specifies the use of revenues the Southeast Valley Community School District will receive from the State of Iowa Secure an Advanced Vision for Education Fund shall be adopted.

To provide funds to acquire or install information technology infrastructure (including improving buildings or sites for the purpose of accessing broadband digital telecommunications) and school safety and security infrastructure.

To provide funds to build and furnish a new school building or buildings; to build and furnish addition(s) to school buildings in the District; to remodel, reconstruct, repair, expand, and improve the school buildings in the District; to purchase and improve grounds; for demolition work; to furnish and equip district facilities.

To provide funds for the purchase, lease or lease-purchase of buildings, equipment (including transportation and recreation equipment), or technology and to repair transportation equipment for transporting students as authorized by law, to implement energy conservation measures, sharing or rental of facilities including a joint infrastructure project for the purposes of offering classes under district-to-community college programs as authorized in Iowa Code Section 423F.3(3)(c), procuring or acquisition of libraries, or opening roads to schoolhouses or buildings.

To provide funds to purchase land as part of start-up costs for new student construction program or if the sale of the previous student construction was insufficient to purchase land, and to purchase construction materials and supplies for a student-constructed building or shed intended to be retained by and used by the District.

To provide funds to make payments to a municipality or other entity as required under lowa Code Section 403.19(2).

To provide funds for demolition, cleanup, and other costs if such costs are necessitated by, and incurred within two years of a disaster.

To provide funds to establish and maintain public recreation places and playgrounds; provide for supervision and instruction for recreational activities; or for community education purposes.

To provide funds for the payment of principal and interest or retirement of general obligation bonds issued for school infrastructure purposes, energy improvement loans, loan agreements authorized by Iowa Code Section 297.36, sales, service and use tax revenue bonds issued under Iowa Code Section 423E.5 or Iowa Code Section 423 E.4.

To provide funds for property tax relief; and

To provide funds for other authorized expenditures and purposes as now or hereafter permitted by law and designated by the Southeast Valley Community School District.

It being understood that if this proposition should fail to be approved by the voters, such failure shall not be construed to terminate or restrict authority previously granted by the voters to expend receipts from the Secure an Advanced Vision for Education Fund.

If approved, this Revenue Purpose Statement shall remain in effect until replaced or amended by the Southeast Valley Community School District.
