 Amending Ordinance No. 111 – Adopted October 19, 2011

Section 1: Purpose

Voting Precinct locations in Boone County – adding to Rural Precinct 2 – **and excluding that part of the City of Boone within Worth Township.**

Section 2: Voting Precinct Boundaries Defined

Boone 1 Precinct: removing language that defines boundaries and replacing with: **As prescribed by the City of Boone.**

Boone 2 Precinct: removing language that defines boundaries and replacing with: **As prescribed by the City of Boone.**

Boone 3 Precinct: removing language that defines boundaries and replacing with: **As prescribed by the City of Boone.**

Boone 4 Precinct: adding: adding (**As prescribed by the City of Boone**) and Des Moines Township:

Boone 5 Precinct: removing language that defines boundaries and replacing with: **As prescribed by the City of Boone.**

Madrid 1 Precinct: removing language that defines boundaries and replacing with: **As prescribed by City of Madrid.**

Madrid 2 Precinct: removing language that defines boundaries and replacing with: **As prescribed by City of Madrid.**

Madrid 3 Precinct: removing language that defines boundaries and replacing with: **As prescribed by City of Madrid.**

Rural Precinct 6: clarifying language: Generally described as Dodge Township except City of Frazier, Harrison Township, and Jackson Township. Bounded as follows, beginning at the intersection of the centerlines of 220<sup>th</sup> Street and "Y" Avenue, thence

north on the centerline of "Y" Avenue or a line projected there from to centerline of 100<sup>th</sup> Street, thence **west** centerline of .....

This ordinance shall be in effect after its passage, approval and publication as provided by law.

Section 5: That this amendment shall be in full force and effect from and after its passage and approval in the manner provided by law.
