ORDINANCE 131

LANDFILL RATES

WHEREAS, the Boone County Landfill is a county enterprise pursuant to Iowa Code Section 331.461 (2015); and

WHEREAS, pursuant to the annual budget process, the Board approves rates and charges for collection of solid waste; and

WHEREAS, the Landfill plans to pledge its revenues for the acquisition of equipment useful in the operation of the landfill; and

WHEREAS, pursuant to Iowa Code section 331.465 where obligations secured by enterprise revenues are anticipated, rates shall be fixed by ordinance; and

WHEREAS, the purpose of this ordinance is to affirm rates currently in place.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF BOONE, IOWA:

Section 1: LANDFILL RATES. The County Landfill enterprise shall accept solid waste in accordance with the attached rate schedule.

Section 2: REPEALER. All Ordinances or parts of Ordinances in conflict with the provisions of this Ordinance are hereby repealed insofar as the conflicting portions thereof are concerned.

Section 3: SEVERABILITY CLAUSE. If any section, provision or part of this ordinance shall be judged invalid or unconstitutional, such shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not deemed invalid or unconstitutional.

Section 4: EFFECTIVE DATE. The rates provided herein shall apply prospectively and retrospectively from July 1, 2015 and thereafter. This ordinance shall be in effect from and after its final passage, approval and publication as provided by Iowa Code (see Iowa Code section 331.302).

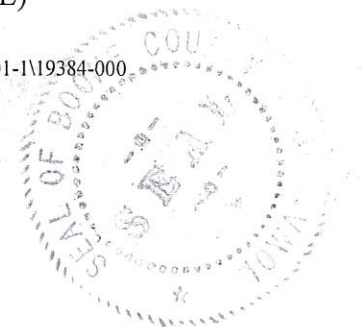

**Note 1: Asbestos disposal requires an appointment.** For residential and commercial structures that have been destroyed by either fire or natural disaster and which must be disposed of as ACM waste in their entirety, the loads must be delivered in bulk and properly packaged. For this type of ACM waste delivered to, and accepted by, the Boone County Landfill shall pay a per ton fee of \$62.00 if a prior written request is submitted to, and approved by, the Landfill Administrator. A minimum fee of \$15.50 will apply to each load of this type of ACM waste.

\* Items must originate from within the Landfill's primary service area.

**Per Capita Users** include residents and businesses located in: Boone County (except Sheldahl); Greene County (except the City of Jefferson); the Cities of Bouton, Granger and Woodward in Dallas County; and the Cities of Farnhamville, Lohrville and Somers in Calhoun County.

**Non-Per Capita Users** include residents and businesses located in Story County. **Non-Per Capita Users must first call the Landfill at (515) 433-0591 to receive authorization prior to delivering a load. Authorization will only be given if the load is rejected by the Ames Resource Recovery Plant in Story County. This does not apply to construction & demolition waste.**
