Area contains 1.07 acres of right of way, and

WHEREAS, the Boone County Board of Supervisors want to make clear that any existing utilities within the right-of-way of the existing roadway shall continue to have the right to access those utilities and make the necessary repairs and upgrades. The said roadway vacation shall not take into effect until the existing Union Pacific Railroad crossing is removed and vacated.

WHEREAS, Boone County did conduct a public hearing at 10:00 am May 31st, 2023 with notice of same being published in the Boone News-Republican on May 18, 2023 and caused same notice to be sent by certified mail to abutting property owners in accordance with Code of Iowa 306.12.

BE IT RESOLVED, that vacation and abandonment is granted and the vacated roadway shall be transferred to the owners of the abutting parcels and railroad right of way as follows, subject to existing utility easements. 1.07 acres transferred to parcel 088426261300003.

BE IT FUTHER RESOLVED, that the Chairman of the Board of Supervisors and the County Auditor are hereby authorized and directed to sign this resolution and cause it to be recorded as the document transferring said vacated street and alleys.
