WHEREAS: The Board of Supervisors of Boone County is empowered under the authority of Sections 321.255 and 321.285, subsection 4 of the Code of Iowa to determine upon the basis of an engineering and traffic investigation conducted by the County Engineer that the speed limit of any secondary road is greater than is reasonable and proper under the conditions existing, and may determine and declare a reasonable and proper speed limit, and WHEREAS: Such investigation has been requested and completed and the county engineer has reached an opinion concerning the reasonable and proper speed for the road listed herein, NOW, THEREFORE BE IT RESOLVED, by the Boone County Board of Supervisors that the following speed limit be established and appropriate signs erected at the locations described as follows:

1) Beginning at the intersection of Noble Lynx Drive and Oriole Road then proceeding west on Noble Lynx Drive to the intersection of Noble Lynx Drive and 231st Road, a speed limit of 25 miles per hour is established.
