WHEREAS, at that August 16, 2023 Public Hearing, the County received a bid in the amount of \$100, for above mentioned property,

WHEREAS, a final public hearing for approval of this Resolution to convey the property to the successful bidder, Stacy Ihrig, was conducted on October 4, 2023;

LET IT BE RESOLVED that a warranty deed for the property legally described as: Sixteen Foot Alley Between Lots 2 & 3 Block 11, in the town of Boxholm situated in the County of Boone, State of Iowa.

BE IT FURTHER RESOLVED that the Chairman of the Board of Supervisors and the County Auditor are hereby authorized and directed to sign and cause the same to be delivered to Stacy Ihrig in satisfaction of accepted offer to purchase real estate.

Board continued Discussion on property at 1214 W 3rd St, Boone- Boone County Held Tax Sale Certificate, Consider Lowering of Back Taxes. Board decided not to lower assessments and fees.

Board continued Public Hearing on Sale of Former County Home Property. Kretzinger moved Bryant seconded the motion that Boone County commission and pay for a memorial at the Boone County Farm Cemetery, to honor those individuals who lived and passed away in the care of Boone County at the former Boone County Poor Farm and Boone County Home. All ayes. Motion carried. Kretzinger moved Bryant seconded the motion that Boone County maintain its ownership of the

former Boone County Home property. Further, that the property will remain known as the Jack and Ilah Long Memorial Park, until such time that Boone County shall name it otherwise. Kretzinger moved Bryant seconded the motion that Boone County develop and enter into an agreement with the Dodge Township Trustees for ongoing management and operating costs of the Jack and Ilah Long Memorial Park. Kretzinger moved Bryant seconded the motion that due to liabilities borne by Boone County for the activities of organizations, clubs, schools and businesses outside of Boone County's control, all activities by these groups in the Jack and Ilah Long Memorial Park shall immediately cease. All such entities, now and going forward, must apply for and receive written approval for organized activities in the park from the Board of Supervisors. Further, that all such entities must provide proof of acceptable liability insurance coverage, with Boone County listed as an additional insured. Ayes: Kretzinger & Bryant. Nayes: Zinnel. Motion carried. Kretzinger moved Bryant seconded motion to close the public hearing. All ayes. Chairman Zinnel closed the public hearing at 11:08 p.m.

Kretzinger moved Bryant seconded motion to adjourn the meeting. All ayes. Motion carried. Chairman Zinnel adjourned the meeting at 11:10 a.m.
