Chairman Kretzinger called the meeting to order at 8:30 a.m. with Kretzinger, Zinnel & Bryant present. Bryant moved Zinnel seconded the motion to approve September 18, 2024 minutes. All ayes. Motion carried.

Zinnel moved Bryant seconded motion to approve agenda as posted. All ayes. Motion carried. Chairman Kretzinger reviewed and placed on file Sheriff's Office Fees Collected for August 2024.

Zinnel moved Bryant seconded motion to adopt Resolution 24-40: Two Applications for Voluntary Annexation to the City of Madrid from Land Force Enterprises, LLC and Madrid Evangelical Church. All ayes. Motion carried.

RESOLUTION NO. 24-40

WHEREAS, the City of Madrid, Iowa ("City") has provided Boone County ("County") with two Applications for Voluntary Annexation to the City of Madrid, Iowa, from Land Force Enterprises, LLC and the Madrid Evangelical Free Church; and

WHEREAS, as outlined in the Application for Voluntary Annexation to the City of Madrid, Iowa, Land Force Enterprises, LLC wishes to have the following legally described real estate, locally known as 2235 S. Avenue, Madrid, IA 50156, be annexed into the City of Madrid, Iowa:

Lot one (1) of Southwest quarter (¼) of Northeast quarter (1/4) and Southeast quarter (¼) of Northeast quarter (¼), except South 600 feet thereof, and 100 feet of the vacated former Chicago, Milwaukee, St. Paul Railway Company right-of-way lying West of and adjacent to Lot one (1) of Southwest quarter (¼) of Northeast quarter (¼), all in Section twenty-five (25), Township eighty-two (82) North, Range twenty-six (26), West of the 5th P.M., Boone County, Iowa.

WHEREAS, as outlined in the Application for Voluntary Annexation to the City of Madrid, Iowa, the Madrid Evangelical Free Church wishes to have the following legally described real estate, locally known as 2243 S. Avenue, Madrid, IA 50156, be annexed into the City of Madrid, Iowa:

Beginning at the South East corner of North East quarter of Section 25, Township 82 North, Range 26, West of the 5th P.M., running thence South 89° 32′ West 1448.94 feet, thence North 0° 32′ West 600.18 feet, thence North 89° 32′ East 1454.52 feet to the East line of said North East quarter, thence South 0° 00′ East 600.4 feet to the point of beginning subject to public highway.

Bryant moved Zinnel seconded motion to open the Public Hearing at 9:01 a.m. All ayes.

Zinnel moved, Kretzinger seconded motion to permit the Conservation Board to spend up to \$90,000 on a dock replacement project at Don Williams Lake that would be included in a Fiscal Year 2025 budget amendment by June 30, 2025, or into next year, all subject to approval by the Iowa Department of Natural Resources of a pending grant application that would reimburse the total amount spent. All ayes. Motion carried.

Zinnel moved Kretzinger seconded motion to adjourn the meeting. All ayes. Motion carried. Chairman Kretzinger adjourned the meeting at 11:08 a.m.
