Kretzinger moved Longhorn seconded motion to approve City of Madrid's request for use of County Roads for Madrid Labor Day Parade September 1st, 2025. All ayes. Motion carried.

Kretzinger moved Longhorn seconded motion to approve awarding the Boone County, Iowa Drainage District No. 112 Proposed Open Ditch Improvement project to Reutzel Excavating, Inc., for the bid amount of one hundred fifty-two thousand one hundred thirty-seven and 00/100 dollars(\$152,137.00). All ayes. Motion carried.

Jonathan Bullock, County Engineer gave a Departmental Update. Kretzinger moved Longhorn seconded motion to approve signing Roadway Maintenance Agreement with Iowa Department of Transportation for Ledges State Park. All ayes. Motion carried. Kretzinger moved Longhorn seconded motion to approve signing Agreement for DOT-Initiated Detour on US 169 from US 169 and E26 to W Jct US 169 and IA 175. All ayes. Motion carried.
